ENFORCEMENT NOTICE UNAUTHORISED DEVELOPMENT

Issued by: Broxbourne Borough Council ("the Council")

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to it that there has been a breach of planning control, under Section 171A(1)(a) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND TO WHICH THIS NOTICE RELATES

134 Northfield Road, Waltham Cross, Hertfordshire, EN8 7RE, shown edged red on the attached plan.

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Carrying out of development without the required planning permission consisting of erection of a front boundary enclosure consisting of masonry wall with metal railings atop and masonry piers.

4. **REASONS FOR ISSUING THIS NOTICE**

It is considered that the unauthorised operational development commenced within the last 4 years as detailed below.

4.1 The unauthorised development causes visual harm to the surrounding amenity and neighbourhood of the area, which is generally open in its character. The resultant effect is overbearing and detrimental to the visual amenity of the area by reason of its height, appearance and materials used in construction that are incongruous with its surroundings contrary to Policies H6, H8, HD13, Hd14 and HD16 of the Borough of Broxbourne Local Plan Second Review 2001-2011 (December 2005) and the Supplementary Planning Guidance August 2004 (updated 2013).

5. WHAT YOU ARE REQUIRED TO DO

- (i) Remove the front boundary treatment in its entirety; or
- (ii) Alter the development so that no part of the front boundary treatment adjacent to a highway is above 1 meter in height.

6. TIME FOR COMPLIANCE

2 month after this notice takes effect

7. WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on 13th March 2017 unless an appeal is made against it beforehand.
