The report overleaf sets out the decision to be taken, the reasons for the decision, and the details of alternative options, if any, considered and rejected. Officer decisions are available for public inspection, both at the Borough Offices and on the Council's website.

Officer decisions are kept for a period of six years at the Borough Offices and for six months on the website after the decision is made. Background papers are available for four years.

RECOMMENDED that:

- (a) the indicative profile of expenditure from generic s106 funds listed in table 2 of the report (attached) to the s106 Panel on 9 March be agreed and
- (b) the considerations for new S106 funded projects as outlined in the attached report be agreed

Purpose

To seek Cabinet Members' approval for the indicative profile of expenditure from generic section 106 (s106 funds). These are listed in table 2 of the report and were presented to the s106 Panel on 9 March 2021 (attached).

To take into account the considerations in reaching decisions on proposed S106 expenditure, also outlined in the report.

The Proposal

Arrangements for member level consideration of expenditure of s106 funds by a Member Panel were introduced in 2019.

The Panel's role is to effectively operate as an advisory body to the Cabinet. Therefore the way the approval process for s106 expenditure will work is that the Panel will make recommendations for the allocation of funds to specific projects. This will be formally agreed by the relevant director or the Chief Executive in consultation with the relevant Cabinet member.

The agreement of each Cabinet member is therefore sought to the indicative profile of expenditure from generic s106 funds listed in table 2 of the report presented to the Panel. In addition, the report sets out the considerations to be taken into account in reaching a decision namely:

Projects which will be using s106 monies must comply with new town planning legislation and the terms of the relevant s106 agreement. The project must also support the Council's priorities and in particular balance the benefits to the local community and economy against the financial implications. The Panel agreed that:

a) future project proposals quantify any revenue implications and identify how they will be funded;

- b) projects should support the Council's corporate objectives as expressed in the Corporate Plan wherever possible; and
- c) where possible, and the relevant legal tests can be met, priority will be given to projects which generate income or save costs.

Cabinet Members asked to agree these considerations.

Financial, Legal and Risk Management Implications

As with all Council spending, the s106 receipts need to be managed and allocated with a high degree of scrutiny and accountability. Improper expenditure of s106 funds could have significant legal and financial implications for the Council.

Alternative Options Considered and Rejected

There are no alternatives to the recommendations.

Equality Implications

There are no equalities implications arising from the recommendation.

Contributions to the Council's Objectives and Environmental Sustainability Priorities

The delivery of s106 infrastructure projects generally supports most of the Council's corporate objectives and priorities.

Conclusion

The resolutions made by the s106 Panel help ensure that s106 receipts are managed to maximise the benefits to the local community, the local economy and help deliver the Council's corporate objectives.

Purpose

To provide an update on the s106 funded projects and the s106 receipts available.

For members' information, Appendix 'A' is attached to this report.

Background

In 2019, a Section 106 member Panel was appointed to provide oversight of, and give consideration to, infrastructure projects to be funded by Section 106 agreements entered into with developers in association with planning applications, except those projects which are already agreed by the Council through the capital programme or for which there is no discretion.

Infrastructure projects are defined as the "provision, improvement, replacement, operation or maintenance" of infrastructure which includes (a) roads and other transport facilities; (b) flood defences; (c) sporting and recreational facilities; and (d) open spaces. Section 106 funding constitutes a significant proportion of the Council's annual capital expenditure.

Process for project authorisation and delivery

The officer Project Management Board (PMB) considers each project which is brought before it to ensure it complies with the statutory tests, aligns with the Council's corporate objectives and meets the aspirations expressed by members of this Panel. If the Panel endorses the project and its funding from Section 106 agreements then the appropriate Cabinet member is advised and their concurrence is sought to proceed with the project.

Once a budget is established the project manager is authorised to deliver the approved project. The PMB will oversee the project's delivery and report progress to the Panel to monitor delivery and expenditure. Additional project management resource is being planned for 2021/22.

Section 106 receipts and infrastructure projects they are funding

The Council holds £11,506,576 of s106 receipts (received up to the end of December 2020). The tables in Appendix 'A' give a detailed breakdown of the infrastructure projects the s106 receipts are funding as summarised in the table below.

A sum of £3,246,245 of s106 receipts is currently available to fund new projects as they are identified.

The deadlines for using the s106 funds and their intended purpose vary from agreement to agreement. Some of the older s106 agreements do not specify spending deadlines and explain the intended purpose of the funds in very general terms. The Panel will therefore play an important part in considering how such generic funds should be allocated to supported projects.

Some s106 agreements are more specific and tend to identify the specific projects for which the s106 funds can be used. In addition, full Council agrees the use of some S106 funds as part of its approval of the capital programme. Such projects are not therefore reported to the Panel for consideration. The key focus for the Council is to ensure that these specific projects are delivered on time and within the approved budget.

Considerations for new s106 funded projects

New projects must comply with town planning legislation, as reported to the Panel meeting in November 2020, and the terms of the relevant s106 agreement. The project must also support the Council's priorities and in particular balance the benefits to the local community and economy against the financial implications. In this respect it is proposed that:

- a) future project proposals quantify any revenue implications and identify how they will be funded;
- b) projects should support the Council's corporate objectives as expressed in the Corporate Plan, wherever possible; and

c) where possible, and the relevant legal tests can be met, priority will be given to projects which generate income or save costs

Financial, Legal and Risk Management Implications

As highlighted in a report to the Panel in November 2020, the s106 receipts need to be managed and allocated with a high degree of scrutiny and accountability. Improper expenditure of s106 funds would have significant legal and financial implications for the Council.

Alternative Options Considered

The alternative is not to have a process for authorising s106 projects as set out in this report, which clearly would not be consistent with the Council's current intentions.

Equality Implications

There are no equalities implications arising from the recommendation.

Contributions to the Council's Objectives and Environmental Sustainability Priorities

The delivery of s106 infrastructure projects generally support all of the Council's objectives and environmental sustainability priorities.

Conclusion

The recommendations as set out at the beginning of this this report will help ensure the Council's s106 receipts are managed to maximise the benefits to the local community, the local economy and help deliver the Council's corporate objectives.
