Dear Marta,

We cannot approve anything straight away without all the surrounding context and full drainage strategy. In principle we would agree discharge to a watercourse a greenfield runoff rate.

Please refer to our SuDS Policy Statement available online (https://www.hertfordshire.gov.uk/services/recycling-wasteand-environment/water/surface-water-drainage/surface-water-drainage.aspx#).

Having a quick look to your site, I must draw your attention on the qualification of the watercourse that runs within the north part. It is currently unmapped and not classified as an ordinary watercourse in this location, but it is downstream. However the applicant must be aware that should the dich serve surface water management as the consequence of the development, it is likely to be classified as ordinary watercourse in the future. This classification comes with rights and responsibilities for the riparian owner under the common law and is also regulated by the Land Drainage Act 1991. We will request assessment of the contributing flow route and an downstream assessment of the watercourse to ensure there is the capacity in the receiving system and that the potential consequence on existing capacity issue are known.
