Dear Peter Quaile,

I am writing to express my familys deep concerns around the proposed development.

Goffs Oak is a beautiful village with wonderful green belt land and an active community. The proposed development and increase in housing will remove the green belt land that is essential for the wildlife we have as well as stretch overburdened services and threaten to destabilise the community that is well established.

The development will remove the natural habitat

for a diverse ecology the supports fauna and flora alike. We regularly see Buzzards, Red Kites, Sparrow Hawks, Jays, tits, finches and even woodpeckers in our garden and the surrounding areas. Most evenings we will see bats flying over our property leaving their nests and our Ring cameras have picked up hedgehogs, badgers, foxes and owls in our garden. The proposed development will impede the natural throughfare for these animals and woodland near the proposed site are resplendent with historic oaks, beech. hornbeam, birch, and horse chestnut trees which create a rich woodland environment that supports mammals, reptiles, birds, insects as well as other flora and all this will be threatened by the proposed development.

The local GP surgeries are oversubscribed making it very challenging to book appointments and access it for non-urgent visits. The introduction of 58 new homes will stress this service which already has issues with capacity.

At present there is extremely high competition for limited space at both primary schools in Goffs Oak which are single form entry. Cuffley school has similar competition levels and the new housing for this development, which will include homes for families, will result in children not being able to access local schooling nd having to travel outside the village which will impact on my next discussion point.

The infrastructure within Goffs Oak and the local adjoining villages can not cope with the current volume of car traffic and Cuffley Hill is often a site for congestion even outside the usual commuter times. To add 58 homes, and the increase in car ownership, just at that development site, will further exacerbate this current issue affecting all residents. This increase in car traffic will also have an impact on local air quality levels especially where cars become stationary all along Cuffley Hill and Goffs Lane affecting all members of our community young and old. This coupled with the increase in noise pollution will negatively impact our residents and the wildlife we live alongside in this rural, village community.

Goffs Oak as at present has several housing developments projects that will swell the population of the village and my family and I hope that the local council will side with the local residents in denying approval for this particular development.
