# **BREACH OF CONDITION NOTICE**

1 **THIS NOTICE** is served by the Council under Section 171A(2)(b) as defined by Section 187A of the above Act because it considers that a condition imposed on a grant of planning permission, relating to the land described in paragraph 2 below, has not been complied with. The Council considers that you should be required to comply with the condition specified in this notice.

The Annex at the end of this notice contains important information.

#### 2 THE LAND TO WHICH THIS NOTICE RELATES

**9 High View Farm, Crouch Lane, Goffs Oak, EN7 6TH** shown edged red on the attached plan.

#### 3 THE RELEVANT PLANNING PERMISSION

The notice relates to the planning permission granted by the Council on 31<sup>st</sup> March 2025 under the reference 07/25/0098/HF for the "Removal of existing Ball Stop Netting and erection of 2.5m high Ball Stop Netting".

#### 4 THE BREACH OF CONDITION

The condition 3 attached to planning permission reference 07/25/0098/HF has not been complied with -

Condition 3: The removal of the existing poles and netting shall be completed within a period of 28 days commencing on the date of this notice. Reason – To ensure the development is carried out as permitted.

#### 5 WHAT YOU ARE REQUIRED TO DO

As the person(s) responsible for the breach of conditions specified in paragraph 4 of this notice, you are required to comply with the stated conditions by taking the following steps:

(i) Remove the existing netting and poles from the eastern boundary fence

#### 6 TIME FOR COMPLIANCE

Step (i) 4 weeks beginning with the date on which this notice is served on you
