TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1950.

WIETEAS the County Council of the Administrative County of Hertford (hereinafter called "the County Council") are the Local Planning Authority for the Administrative County of Hertford by virtue of the Town and Country Planning Act, 1947.

AND WHEREAS the County Council are satisfied that certain development of the classes specified in the First Schedule to the Town and Country Planning General Development (rder, 1950 should not be carried out in certain areas within the Administrative County of Mertford unless permission is granted on an application in that behalf.

THEREFORE the County Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order, 1950 and all other powers enabling them in that behalf Direct that permission granted by Article 3 of that Order shall not apply to any development specified in the First Schedule hereto in the areas specified in the Second Schedule hereto.

THIS Order may be cited as "The Hertfordshire County?" Council (Town and Country Planning) (Direction restricting permitted development) No. 1 Order, 1951."
